

## **STUDENT & PARENT AGREEMENT FOR HDSC TRAVEL**

In allowing my son/daughter to travel to and from Hamilton District Skills Centre (as detailed on the signed indemnity form), I agree to the following conditions:

1. I agree to pay the designated cost of the service in advance unless a prior arrangement has been made with the Principal. No costs are to be borne by the teachers, the Principal of Casterton Secondary College or the Department of Education and Early Childhood Development.
2. I authorise the teacher in charge/bus driver to consent, where it is impractical to communicate with me, to the child receiving such medical or surgical treatment as maybe deemed necessary.
3. If other costs arise in relation to the transport, which in the opinion of the supervising teacher/bus driver are necessary to incur to preserve the health or safety of students, I will reimburse them for such costs.
4. In the interest of the safety and well-being of all students, my son/daughter is expected to observe the following points:
  - No alcoholic liquor, illegal drugs or cigarettes will be brought, acquired or consumed on the trip or during the day at HDSC.
  - No dangerous or illegal equipment/weapons will be brought or acquired on the trip or during the day at HDSC.
  - Should the teacher/bus driver in charge deem it necessary, students will allow their property to be searched for substances that have been banned by the school.
  - Students will remain seated and wear seat belts at all times when on the bus.
  - Students will keep noise to a minimum level and behave in a safe manner at all times, so as not to compromise the safety of other passengers or cause distraction for the driver.
5. I understand that at all times students are expected to observe conduct consistent with common sense and to obey the instructions of teacher/bus driver or other supervising adults. I also understand that should students not behave appropriately, they may be returned to the school as soon as practical and that their parents will be expected to meet any expenses that this may entail. Students may also be banned from using this bus service for future trips to and from HDSC.
6. I understand that my son/daughter will be wholly responsible for any valuables. The teacher/bus driver, school and the Department of Education and Early Childhood Development do not carry insurance for personal property, and will not accept responsibility for students' property.
